WHEREAS, Utility Collector Renee James has indicated that due to a clerical error, the utility bill for Block 27; Lot 4.03, Utility Account #274-0 needs to be adjusted, **and**

WHEREAS, the error occurred when a disconnected change was not correctly posted to the account during the billing period of April 1, 2020 through June 30, 2020, **and**

WHEREAS, the account was billed a portion of second quarter of 2020 and minimum billed for the third quarter of 2020, **and**

WHEREAS, the water account needs to be adjusted \$16.80 for second quarter and \$108.72 third quarter, a total of \$125.52 **and**

WHEREAS, the sewer account needs to be adjusted \$33.88 for second quarter and \$220.75 for third quarter, a total of \$254.63.

RESOLUTION OF THE BOROUGH OF LAKEHURST, COUNTY OF OCEAN, STATE OF NEW JERSEY, IN SUPPORT OF INCREASING THE SOCIAL SECURITY COST OF LIVING ADJUSTMENT

WHEREAS, Ocean County is home to the largest senior population in the State of New Jersey, with many of the 173,000 seniors living solely on Social Security receiving about \$1,500 per month to cover housing, food, medications and utilities; and

WHEREAS, the Social Security Administration recently announced the Cost of Living Adjustment (COLA) for Social Security recipients was a mere 1.3 percent for 2021; and

WHEREAS, the current increase of 1.3 percent falls far short of recent cost of living increases especially as it relates to the coronavirus pandemic; and

WHEREAS, U.S. Representative Christopher H. Smith, 4th District, and U.S. Representative Jeff Van Drew, 2nd District, in concert with the Ocean County Board of Chosen Freeholders has voiced their frustration over the low increase in benefits; and

WHEREAS, Congressman Smith along with Congressman Van Drew have introduced legislation in an effort to help all seniors relying on Social Security as their sole monthly income, that would provide an immediate, 2-year emergency 3 percent COLA, including 2020 and 2021, during the national COVID-19 emergency; and

WHEREAS, HR 8600, the COVID-19 Emergency Social Security Cost of Living Increase Act, is aimed at helping seniors and other Social Security recipients keep up with rising costs they experience in their daily lives, especially in health care, and

WHEREAS, Congressman Smith and Van Drew's proposed legislation will also require the Social Security Administration to determine the annual COLA by using a senior consumer price index beginning in 2021; and

WHEREAS, the proposed measure would change the formula so that it gives appropriate weight to the types of expenses which recipients of Social Security and Supplemental Security Income (SSI) regularly face including rising medical and pharmaceutical expenses.

NOW, THEREFORE, BE IT RESOLVED, that the Mayor and Council of the Borough of Lakehurst, County of Ocean, State of New Jersey soundly supports the efforts of Congressman Smith and Van Drew to correct the inaccuracies of the SSA COLA formula while also implementing a 2-year emergency 3 percent COLA to help protect our seniors from financial hardships and allow them to continue to live independently without the fear and anxiety that comes from financial concerns.

BE IT FURTHER RESOLVED that the Mayor and Council encourages all of the Congressional leadership to support and expedite this legislation in order to protect the elderly population that is the most vulnerable and frail.
