Municipal Clerk Capasso reviewed the regular meeting agenda.

Councilman DiMeo asked if there was any movement concerning 6 Union Avenue.

Borough Attorney Ian Goldman responded a letter was sent to the owner yesterday stating the danger that the building imposes on public safety and that it must be demolished immediately.

Council President Oglesby asked if the owners were given a time frame.

Mr. Goldman responded no time frame was given adding he had given them a time frame with the first letter of concern.

Mayor Robbins stated that the borough will give them till end of next week and then will take action to demolish the building adding a lien will be placed on the property for the cost of the demolition.

Mr. Oglesby suggested the borough purchase one or two drones. Mr. Oglesby stated drones are now inexpensive and that they would be a multi-use tool for all borough departments. Mr. Oglesby further stated public works can do water tower inspections, police could use it if they were searching for someone, and the code enforcement officer could use one instead of stepping foot on to someone's property.

Mayor Robbins responded the borough is in a no-fly zone and would have to obtain special permission adding it should not be problem for a municipality to obtain.

Councilman Lowe questioned the trees along Maple Street that are lifting the sidewalks and having public works cut the trees down.

Mayor Robbins responded it is the homeowner's responsibility.

Mr. Goldman responded sidewalks lifting causing a tripping hazard is more likely a borough issue adding the borough could be named in a lawsuit. Mr. Goldman stated if there is an issue with the sidewalks coming up, the borough needs to be notified and then address it.

Mr. Lowe responded the borough can have Public Works go over to the site and measure the sidewalk. Mr. Lowe stated if there is a tripping hazard, public works can remove the tree and "skim" the sidewalk down to eliminate any lifts.

Mr. McCarthy stated he will each out to Dave Winton, Public Works Department Head, advising him there is equipment that will grind down cement.

Council President Oglesby reported the Personnel Committee report will be during executive session. Mr. Oglesby also reported the Ordinance Committee along with the borough attorney are putting "tweaks" on the parking at the lake ordinance adding they will present to councilmembers at the next meeting.

Councilman McCarthy reported for the Public Safety Committee the fire department has a new fire chief, Danny Dries adding he is a lifelong resident of the borough. Mr. McCarthy also reported the fire department made a purchase to update the department to be compliant with OSHA adding it is a tag system on the equipment to account for their where abouts in a fire. Mr. McCarthy further reported Sharon Van Berkel, Police Records Clerk is retiring after being with the police department for over 30 years. Mr. McCarthy went on to report Detective Robert Schroeck resigned adding Chief Kline would like to move a Lakehurst Police Officer laterally into the detective position.

Mr. McCarthy reported the Board of Education had a Friday, 9:00am, special emergency meeting adding he was unable to attend. Mr. McCarthy also reported on the agenda there was no monthly bills statement but it did state September 30th balance of \$173,173.21. Mr. McCarthy further reported the agenda had multiple topics like personnel, monthly budget items, and announcements and added it was basically a regular meeting.

Mr. Oglesby asked if a special emergency meeting is called, are you restricted by law to publish the nature of the urgency.

Mr. McCarthy responded that is the open public meetings act adding the Board of Education agenda does not state the emergency.

Mayor Robbins stated Dr. Klohn had sanitary back up into his office the other night and was worried he would have to cancel all appointments the following day. Mayor Robbins further stated public works came out in the evening to repair the problem. Mayor Robbins quoted Dr. Klohn "I am blessed to be in the Borough of Lakehurst".

Mayor Robbins reported there will be no Tree Lighting Ceremony this year due to the pandemic.
