COMMITTEE/COUNCIL REPORTS:

Councilwoman Hodges reported the Public Works Committee met with Dave Winton, Public Works Department Head. Mrs. Hodges stated Mr. Winton had interviewed a candidate for the T-120 position. Mrs. Hodges also stated the target date for the portable bathrooms is February.

Council President Oglesby reported JCP&L puts out a questionnaire every year asking residents who have special needs with equipment and added if there is a power failure, they would get high priority. Mr. Oglesby urged residents to fill out the questionnaire.

Mayor Robbins asked if the questionnaire is also for residents who have wells.

Mr. Oglesby responded wells are a necessity adding those residents too should fill out the questionnaire.

Mr. Oglesby reported the Ordinance Committee has a completed draft of the Lake Ordinance for the council to review and added the committee would like to introduce at the regular meeting in January.

Mayor Robbins stated the next ordinance that needs to be reviewed is the zoning for medical use facilities. Mayor Robbins informed the ordinance committee that doctor offices, or any medical use office, are not a permitted use in the borough.

Mrs. Hodges responded the ordinance does not prohibited the use either.

Mayor Robbins responded the ordinance needs clarity.

Councilman Lowe reported there were a few minor repairs to the garbage trucks including regular maintenance. Mr. Lowe also reported the police department purchase CPR mannequins for training. Mr. Lowe stated a police officer will be receiving training to be a certified instructor adding the officer can then train "in-house" saving the borough money.

MAYOR COMMENTS:

Mayor Robbins reported the owner of the former Burger King property had contacted him to see what business the borough would like to see there. Mayor Robbins stated he mentioned an auto parts store adding the closes one is in Toms River. Mayor Robbins also mentioned the residents are expressing a chicken restaurant like Kentucky Fried Chicken, Popeyes, or Chick-fil-a. Mayor Robbins stated the owner asked if a marijuana dispensary would be considered. Mayor Robbins further stated that he informed the owner that he cannot make that decision. Mayor Robbins went on to say the owner's son who has been in the business for six years would like to speak to the governing body as well as the Land Use Board, to discuss what the benefits would be to the borough

Council President Oglesby questioned the two hundred feet from the school.

Mayor Robbins responded marijuana is now legal adding that might not be a concern.

Mr. Oglesby stated there are questions for the Land Use Attorney to considered now with regulation changes.

Mayor Robbins stated there is the possibility of the borough benefiting from levying an extra tax on what is being sold.

Mayor Robbins also stated he spoke with Dave Winton, Department Head of Public Works, in regard to next year's Community Development Block Grant adding he would like to utilize the grant to address the removal of trees that are causing sidewalks to lift and to repair of the sidewalks.
