#### COMMITTEE/COUNCIL REPORTS:

Councilwoman Hodges reported herself and Mr. McCarthy met with Public Works Department Head Dave Winton, Daniel Dries and Bryan LeVance. Mrs. Hodges stated that the pear tree project is basically done and catch basins were cleaned. Mrs. Hodges went on to say that the 2024 NJDOT bid was rejected.

Mayor Robbins went on to explain that our award was for \$197,000.00 and the bid came in at \$220,000 that is why we rejected it.

Councilwoman Hodges said that Dave Winton is looking for some ideas for the 2025 CDBG grant adding the grant amount would be about \$35,000.00.

Councilwoman Dugan responded maybe bathrooms at the ballfield.

Councilwoman Hodges went on to say that Mr. Winton is going to put in for a lake lowering permit, but he is not confident that he will get it. Mrs. Hodges stated that Mr. Winton is going to continue bulkheading either way. Mrs. Hodges also stated that there was talk about an automated garbage truck.

Councilwoman Dugan reported that the July 4<sup>th</sup> car show was wonderful. Mrs. Dugan also stated that on September 18, 2024, Mike Mahoney will discuss the history of Lakehurst and Manchester adding it's free of charge and light refreshments will be served.

Councilman McCarthy reported that Public Safety attended the OEM meeting last night to discuss the July 3<sup>rd</sup> and July 4<sup>th</sup> and all the emergency services. Mr. McCarthy stated that everything went well and will continue as is. Mr. McCarthy also wanted to remind everyone that we have no lifeguard and there is absolutely no swimming. Mr. McCarthy went on to say that the new patrol unit is complete and on the road. Mr. McCarthy reported that Pine Beach was very generous with the acceptance of our offer for the light rescue pumper adding the truck has low hours; however, the downside is the tool storage is smaller, and we have to transfer the lights from our other truck. Mr. McCarthy stated that this truck will replace the 1995 Marion.

Councilman Oglesby reported the Ordinance Committee met with the Chief of Police and the Code Enforcement Officer and there are a few areas that they are looking at and that progress is being made.

#### **COMMENTS FROM PUBLIC:**

Jeff Wolff, 211 Lilac Street voiced concerns with having a dispensary behind his house and asked where he could voice his opinion.

Mayor Robbins stated that the cannabis retailer bought the building but does not have a state license yet. Mayor Robbins also stated that they still need to go in front of the Land Use Board at which time a 200-foot notification will be sent to residents notifying them of the meeting where they can voice their concerns.

Attorney Ian Goldman stated that the Borough created an ordinance that allowed a second license on the West Side of Route 70. Mr. Goldman also stated that applications were submitted and the one that was chosen was the best for the town. Mr. Goldman went on to say that the building is in the business district, and it is currently a law firm so the new owner will have to apply for a change of use adding that a dispensary is a permitted use.

Tom O'Brien, 516 Cedar Street, stated that there are only about 6 people within 200 feet so he feels they will not be heard.

April Chillemi, 215 Manapaqua Avenue, wanted to thank everyone for the car show and the fireworks. Mrs. Chillemi also asked if there is a little money, there is a small dirt street that runs between her and the neighbor's house and a piece of property is located back there and is landlocked, maybe the town could pave that street.

Katie Wolff, 211 Lilac Street, wanted to know if one of the small trash cans on a pole could be placed on Lilac Street. Mrs. Wolff stated that there is always trash and bottles ending up in her yard.
