Mr. McCarthy answered there is existing plumbing available and added that an electrical outlet will have to be installed.

Mr. McCarthy responded in the affirmative.

Mayor Robbins stated that as long as there is no personal use of the machines, he has no problem with the installation of the commercial machine.

Mr. Oglesby stated that he is not opposed to the installation but did ask if the water supply is sufficient for commercial use.

Mayor Robbins confirmed that the installation will be completed by a licensed plumber and licensed electrician asking if the governing body had any concerns or questions.

COMMITTEE/COUNCIL REPORTS:

Councilwoman Dugan thanked all that expressed confidence in her and added that it was nice see all that came out to vote on election day.

Councilman McCarthy commended the police department for a job well done adding that there will be a press release forth coming. Mr. McCarthy reported that the fire department's vendor fair is this Saturday at the ESC center from 10am to 3pm, adding that there will be five food trucks and twenty-one vendors.

MAYOR COMMENTS:

Mayor Robbins announced that the Veteran's Day Ceremony is this Monday, November 11th, at 11:00 a.m. at Lake Horicon. Mayor Robbins also announced the Ocean County Health Department will be having their Flu and COVID clinic at the Lakehurst

Community Center on November 19th, from 1:00 pm to 4:00 pm. Mayor Robbins further announced that the next council meeting will be December 5th.

COMMENTS FROM PUBLIC:

Time opened: 7:39 p.m.

Gerry Nieuwenhuizen, 601 Poplar Street, stated that he received a warning from the Code Enforcement Officer regarding his Lilac Bushes adding that the bushes are between 8 to 10 feet tall, and the Code Enforcement Officer stated that they need to be 2 feet tall.

Mayor Robbins responded that if the bushes do not obstruct the line of sight at the corner, then there should be no issues adding that he will reach out to the Code Enforcement Officer, William VanBerkel.

Mr. Nieuwenhuizen stated that Code Enforcement Officer stated that there are things "coming down the pike" that might make residents unhappy.

Mayor Robbins reported that he had a long conversation with Mr. VanBerkel regarding warnings, adding that there will be only one warning with 14 days to respond to the warning. Mayor Robbins stated that a majority of the residents do take care of their property; however, there are a few that do not and those who do not will be ticketed.

Bruce Margeson, 5 Geneva Road, congratulated Bernadette Dugan and all the other candidates. Mr. Margeson also congratulated Crystal Parker for stepping up, adding we certainly need more citizens to challenge each and every council member, "keeping them on their toes". Mr. Margeson thanked the Code Enforcement Officer for having the gas station finally cleaning the property from tires, garbage, and overgrown grass. Mr. Margeson wished everyone a Happy Thanksgiving.

Sue Clark, representing the Fire Department, stated that Pizza with Santa will be December 2nd at the Lakehurst Community Center from 6:00 pm to 8:00 pm. Adding the cost is \$7.00 for pizza, chips, and soda; however, Proving Ground Church has picked up the cost in the past. Mrs. Clark also stated that the fire department will be offering gift wrapping for a donation on December 14th at the Lakehurst Community Center. Mrs. Clark further stated that the fire department will be having another vendor fair this coming May, the same day as the Town-Wide Yard Sale.

Mr. Margeson thanked James Davis for all he has done for the Borough of Lakehurst and a happy retirement.

Crystal Parker, 206 Pine Street, congratulated Bernadette Dugan and Jeff Emmons on a successful election. Mrs. Parker also thanked everyone who had voted for her, adding she was pleasantly surprised. Mrs. Parker went on to state that the Code Enforcement Officer

needs to "pick his battles" adding he is writing tickets for things like plants being too tall or for parking on the grass. Mrs. Parker reported that she had expanded her apron so that she can expand her driveway; however, she does not have the money at this time to pave it. Mrs. Parker stated that she would rather receive a \$75 fine for parking on the grass than spend thousands to pave.

Mayor Robbins responded that an ordinance is an ordinance and if the Code Enforcement Officer sees something breaking the ordinance, he has to act on it adding there is an ordinance for no parking on the grass and an ordinance for driveways having a setback of 10 feet from the property line. Mayor Robbins also stated that there are exceptions to be taken into consideration.

Mr. Nieuwenhuizen asked how often are the borough ordinances reviewed.

Council President Oglesby responded that the ordinances were reviewed a year and a half ago.

Mayor Robbins added that he had put together an Ordinance Committee to review the ordinance and make necessary changes such as removing ones from years past, adding new ones, and amending those that seem fit.

Mrs. Parker stated that a lot of the residents are upset that they are receiving warnings or tickets, adding there are many residents that do keep the yards clean and are volunteers with the fire department.

Borough Attorney Casandra Destefano responded the Code Enforcement Officer needs to be as mutual as possible. Ms. Destefano added that there is a process that the Code Enforcement Officer has to follow, he issues a violation with a 14-day warning then the ticket is issued with a possible court appearance.

Mr. Oglesby stated that there is a criteria that the Code Enforcement Officer has to follow adding if it is a hazardous situation then it has to be dealt with immediately, if it is a normal situation then it's the 14-day, and if it is a seasonal issue or expensive issue then there has to be a timeline. Mr. Oglesby stated hypothetically, maybe the Code Enforcement Officer can give a lead way, a driveway can be expensive and now that the cold weather is starting to set in.

Mrs. Parker thanked Mr. Oglesby for the clarification of different levels of enforcement.

Mr. Nieuwenhuizen questioned parking within 50 feet of a stop sign.

Ms. Destefano answered the New Jersey statue is 25 feet.
